



CONSTITUTION OF THE PRINCIPALITY OF NORAUTHWIK

Ratified and Approved by the III Parliamentary Session
NorWakian Parliament of Ministers

PREAMBLE

THE PRINCIPALITY OF NORAUTHWIK, hereinafter referred to as *NorAuthwik* or the *Principality*, united by our shared vision and commitment to fostering outreach and initiative of camaraderie, collaboration, creativity, and innovation,¹ which progressively leads to our MicroNational identity, do hereby declare our cultural and internal administrative autonomy over our governing bodies and offices, and herewith declare our right to administer our mission, work, and principles upon which are fundamental to our culture. Herewith establishing this Constitution that shall serve as the foundational framework for the Principle led MicroNation, a Principality as a usage of Principality, and Principles , utilizing

the values and concepts of our Founding Principles, and establishing the governance, laws, and policies of NorAuthwik, as well as the serving standard for any business, industry, nonprofit, or outreach that may come forth from the MicroNation. Founded upon the chief and cornerstone principles of **cultural cultivation**, **unity through community engagement**, **self-expression**, and **liberation through the arts**, fostering an inclusive cultural identity, the Principality of NorAuthwik stands as a voice of freedom and rights of self-expression, with locality based within the physical entity of North Carolina and utilizes digital system for the outreach towards the greater world; Operating in full compliance with the laws of the United States of America, and is committed to upholding and protecting the rights of all its citizens, members, allies. We are not a secessionist or separatist movement, bipartisan party, or anarchist state. We are a mission, legally the Crown of NorAuthwik, LLC. focused upon our Principles, embracing art, and utilizing the status of MicroNation to create the expression of a Princip(les)ality.

ARTICLE I: NAME, SOVEREIGNTY, AND INTERNAL GOVERNANCE

Section 1: Name

The entity shall be known as *The Principality of NorAuthwik*, or as NorAuthwik. This entity shall operate legally through *The Crown of NorAuthwik LLC*, which functions as the governing body for all administrative and economic matters.

Section 2: Sovereignty

NorAuthwik asserts itself as a Principality, exercising full administrative and cultural autonomy, expressed as sovereignty, over its internal governance, administration, and operations. This sovereignty includes the regulation of cultural activities, governance of policy, and control of public initiatives while operating within the legal basis of the greater political and legal empire of the United States of America. NorAuthwik does not seek secession but exercises autonomy over its affairs as a principality within its operating mission and territory.

Section 3: Legal Entity

NorAuthwik shall be represented in all legal and economic matters by *The Crown of NorAuthwik LLC*. This LLC will manage all administrative functions, business endeavors, and legal obligations of NorAuthwik, ensuring compliance with external legal systems while promoting the Principality's cultural and operational objectives.

ARTICLE II: MISSION AND PRINCIPLES

Section 1: Mission

The mission of NorAuthwik is to foster an environment of creativity, artistic self-expression, and community collaboration. Through cultural initiatives and community engagement, NorAuthwik aims to cultivate a unique identity rooted in inclusivity and mutual respect, empowering its citizens to contribute to the Principality's ongoing growth.

Section 2: Core Principles - The Foundation of NorAuthwik

NorAuthwik is a Principality due to its guiding and foundation Principles. Officially explained as a Princip(les)ality.

1. **Cultural Cultivation:** We preserve and celebrate the traditions, heritage, and artistic contributions of NorAuthwik's citizens, fostering a continuous cultural evolution through active participation.
2. **Self-Determination (Liberation) through the Arts:** NorAuthwik empowers its citizens to express their individual and collective identities through various forms of art, using creativity as a pathway to personal and societal liberation.
3. **Unity through Community Engagement:** We promote unity through volunteerism and civic engagement, encouraging citizens to contribute to the community's welfare and shared mission.
4. **Inclusivity and Mutual Respect:** NorAuthwik upholds inclusivity, ensuring that all citizens are treated with respect, and that diverse voices are not only heard but celebrated.

ARTICLE III: GOVERNANCE STRUCTURE

Section 1: The Sovereign

The Sovereign Prince or Princess of NorAuthwik: This role is the MicroNational Head of State, and the administrative and cultural leader of the Principality. The Sovereign is entrusted with the duty to protect NorAuthwik's principles, oversee its operations, ensure the continuation of government, and guide its long-term strategic vision. The Sovereign shall exercise executive authority over all governmental functions.

Section 2: The Prime Minister

The Prime Minister, appointed by the Sovereign, shall lead the daily administrative functions of NorAuthwik and advise the Sovereign on matters of state or interest. The Prime Minister oversees the legislative process, directs policy implementation, and ensures the effective management of national affairs in alignment with NorAuthwik's mission and principles. The Prime Minister leads diplomatic initiatives, and acts, when approved by the Sovereign, on behalf of the Crown.

Section 3: The Parliament

The Parliament of NorAuthwik shall consist of ministers appointed by the Sovereign and Prime Minister, with each minister responsible for a specific department of governance. Parliament shall have the authority to propose, debate, and enact laws that reflect the values of NorAuthwik, subject to royal assent. Each ministry shall act to further the goals of NorAuthwik

in areas such as cultural development, education, diplomacy, and public service.

ARTICLE IV: INTERNAL SOVEREIGNTY AND GOVERNANCE POLICIES

Section 1: Administrative Sovereignty

NorAuthwik shall maintain administrative control over all internal governance, including cultural projects, community initiatives, and public services. This sovereignty, which is legal autonomy, extends to all decisions concerning the organization and execution of activities within the Principality.

1.2. NorAuthwik's administrative sovereignty does not conflict with external legal frameworks but works to complement them to ensure cultural and operational autonomy.

Section 2: Governance Policies

All governance policies and procedures shall be established in accordance with NorAuthwik's principles. These policies shall cover the administration of laws, the management of cultural activities, and the regulation of community participation. Parliament shall create and implement such policies, ensuring alignment with the mission of fostering creativity, unity, and inclusivity.

ARTICLE V: CITIZEN RIGHTS AND DUTIES

Section 1: Rights

Good-standing Citizens of NorAuthwik are entitled to the following rights:

- The right to participate in cultural activities without discrimination.
- The right to peaceful assembly, civic participation, and inclusion in governance processes.
- The right to the freedom of expression within the activities and discussions of NorAuthwik.
- The right to equal protection under the laws of NorAuthwik, irrespective of race, gender, religion, sexuality or macronational nationality.
- **Rights of Good Standing:** Any citizen who adheres to their oath of citizenship, fulfills their obligations and abides by the laws of NorAuthwik shall enjoy all the rights and privileges of citizenship and be recognized as in good standing with the government.

Section 2: Duties

Citizens are expected to:

- Uphold the principles of NorAuthwik and abide by its laws.
- Support participation in community service, volunteerism, and cultural development.
- Respect the rights and freedoms of other citizens, fostering an environment of inclusivity and mutual respect.

- Contribute to the collective cultural heritage of NorAuthwik.
- Oath of Citizenship: Citizens must honor their oath of citizenship, committing to uphold the principles and values of NorAuthwik.
- Fulfillment of Obligations: Citizens are required to fulfill their obligations, including the payment of workshop fees and other dues if applicable, to support the activities and initiatives of the Principality.

ARTICLE VI: DIPLOMACY AND INTERNATIONAL RELATIONS

NorAuthwik shall engage in diplomatic efforts aimed at fostering goodwill, cultural exchange, and mutual cooperation with other MicroNations and international entities.

1.2. Diplomatic relations will reflect NorAuthwik's core principles, ensuring that all external engagements enhance the nation's cultural mission and strategic goals. NorAuthwik remains committed to peaceful and respectful diplomacy that furthers its interests on the global stage.

ARTICLE VII: ECONOMIC FRAMEWORK AND CULTURAL SUSTAINABILITY

Section 1: Economic Sustainability

The Crown of NorAuthwik LLC shall be responsible for all economic activities related to the Principality. These activities shall include, but are not limited to, the generation of revenue through cultural programs, artistic ventures, and public services.

1.2. All economic endeavors shall be conducted in a manner consistent with NorAuthwik's principles, ensuring the sustainability and growth of the nation's cultural initiatives.

Section 2: Reinvestment of Resources

All profits and resources generated through *The Crown of NorAuthwik LLC* shall be reinvested into the Principality, through its sovereign fund which supports the cultural and community programs of NorAuthwik, with a focus on expanding the reach of artistic and educational projects. Financial decisions shall be made transparently and in the best interest of the Principality and its citizens.

ARTICLE VIII: AMENDMENTS AND REVISIONS

Section 1: Amendment Proposals

Amendments to this Constitution may be proposed by any member of Parliament or by citizen petition. Such proposals shall be debated and require a greater majority vote of Parliament, followed by ratification from the Sovereign.

Section 2: Sovereign Assent

All amendments to the Constitution must receive the formal assent of the Sovereign Prince or Princess, whose approval shall be final and binding.
